

Terms and Conditions for appointment on part time basis

- 1) The filled up application may be sent to Director Incharge National Research Institute of Unani Medicine for Skin Disorders, Hyderabad with the self-attested photocopies of the certificates/testimonials of the applicant.
- 2) The engagement will be initially for a period of one year further extendable on the basis of performance of the candidate. However, the appointment can be terminated at any time by the Director, NRIUMSD, Hyderabad without assigning any reason thereof.
- 3) However, the appointee shall give at-least one month's notice for discontinuation to this Institute
- 4) The appointee shall not be entitled to any benefits like PF, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc. or any other benefits as admissible to the regular Government Servants. Non-practicing Allowance is also not admissible to the appointees.
- 5) The appointee shall not have any claim or right for regular appointment in the Institute.
